Package Outline Dimensions

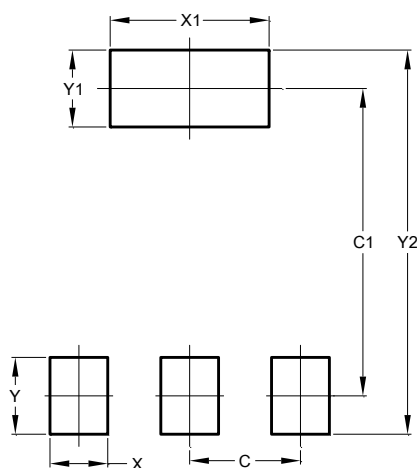
